FINAL ORDER

On December 3, 2009, Karen Schmitt filed Tenant Petition (TP) 29,784 and alleged that Linda Lantz violated various provisions of the Rental Housing Act of 1985, D.C. Official Code §§ 42–3501.01 – 3509.07. This administrative court scheduled this matter for mediation on May 19, 2010 at 9:30 a.m. The parties appeared for mediation, with Administrative Law Judge Claudia Crichlow serving as the mediator. On June 3, 2010, this administrative court scheduled this matter for a prehearing telephone conference on June 17, 2010, at 4:30 p.m. and an evidentiary hearing on June 25, 2010, at 9:30 a.m. On June 14, 2010, Housing Provider/Respondent, through Counsel, filed a motion for continuance for the June 25, 2010, hearing date. During the prehearing conference call on June 17, 2010, the parties agreed to engage in a further mediation session prior to scheduling a hearing on the merits. On June 23, 2010, this administrative court issued an order canceling the June 25, 2010, hearing date and scheduling a mediation for July 2, 2010, at 9:30 a.m. On June 24, 2010, the parties filed a joint

motion to continue the July 2, 2010, mediation. On June 25, 2010, this administrative court

granted the motion and rescheduled the mediation for July 15, 2010, at 9:30 a.m. The parties

appeared for mediation and resolved all issues in the tenant petition and submitted a joint motion

to dismiss the tenant petition with prejudice.

The District of Columbia Administrative Procedure Act, at D.C. Official Code

§ 2-509(a), provides that a contested case may be disposed of by agreed settlement. In addition,

1 DCMR 2817.3, the OAH rule governing voluntary dismissals, provides that "parties, or their

authorized agents or representatives, also may file a stipulation of voluntary dismissal with

prejudice, signed by all parties, their authorized agents or representatives, who have appeared in

the action to dismiss an action." Since the parties have filed a joint motion for voluntary

dismissal with prejudice, the court will dismiss this action in accordance with 1 DCMR 2817.

Therefore, it is this 23rd day of July 2010:

ORDERED, that the parties' joint motion for voluntary dismissal is hereby **GRANTED**;

and it is further

ORDERED, that Case No. 2009-OAH-DHCD-0000062, Agency No. TP 29,784 is

hereby **DISMISSED WITH PREJUDICE**; and it is further

ORDERED, that the appeal rights of any party aggrieved by this Order are set forth

below.

If the final order is served on the parties by mail, an additional three (3) days shall be allowed, in accordance with 14 DCMR 3802.2.
